- 2. Income Tax/Professional tax clearance Certificate/declaration by way of affidavit in this regard.

After receipt of the offer letter, selected owner of t he vehicle must place the vehicle and submit the following documents (original and photocopy) to the Secretary, Paschim Medinipur Zilla Parishad within 7 (seven) days from the date of receipt of offer letter.

- a. New registration (Commercial) with valid certificate of fitness and date of expiry.
- b. Valid Tax Token No. and date of its expiry.
- c. First party insurance certificate with name of the Insurance Company and date of expiry.
- d. Contract carriage permit number with date of expiry and designation of permit issuing authority.

The owner of the vehicle has to give consent in written about the following "Terms and Conditions" of hiring:

- 3. The vehicle shall be in very good running condition and commercial one.
- 4. The consumption of diesel and other lubricants shall be borne as per Notification / Orders of the Government of West Bengal, issued from time to time subject to the receipt of allotment of fund from the Government.
- 5. The cost of removing or repairing of machinery defects and all other maintenance are to be borne by the owner himself.

- 6. The owner will be paid hire charges for the dates on duty only.
- 7. The vehicle if necessary shall be released on giving one month's notice. On the other hand the owner is at liberty to withdraw the vehicle on one month's notice prior to the actual date of withdrawal of the vehicle.
- 8. The payment of the owner of the vehicle shall be made by A/C Payee Cheque on calculation of dates of duty and he prescribed rate of hire charges as per Notification / Orders of the Government of West Bengal, issued from time to time subject to the receipt of allotment of fund from the Government.
