- 5. Each page of Tender shall be signed by the Tenderer before submission of Tender Paper.
- 6. The kind of supply must be written on the envelop.
- 7. The tenders, which do not fulfill any of the above conditions or incomplete in any respect, are liable to be summarily rejected.
- 8. Payment will be made from the Office of the District Officer, F.P.I & Horticulture, Paschim Medinipur after successful delivery to the office.
- 9. The entire quantity of the material should be supplied within 7 days after issue of the supply Order.
- 10. The authority reserves the right to reject or accept any or all tenders without assigning any reason whatsoever.
- 11. The authority is not bound to accept the lowest tender.
- 12. If the successful tenderer denies to accept the offer letter then his Earnest Money will be forfeited. In case of failure to complete the supply work within the stipulated time, his offer letter will be cancelled and Security Deposit will be forfeited without assigning any reason thereof.
- 13. In case of successful tenderer the Earnest Money will be converted into Security Deposit.
- 14. The Tenderer shall have to submit the attested photocopy of all related documents along with the tender paper.
