The scope of work should be comprises of all parameters as noted below:-


1. Collection of all necessary Geo-reference data of attributes from field as specified in DRRP formats for PMGSY-II & III as per guideline of NRIDA.
2. Preparation of CAD compatible maps with the specified GIS data. All the co-ordinates of the attributes shown on drawing should be exactly match with actual latitude & Longitude of the respective attributes on field.
3. Consultant will assist EE, WBSRDA, Paschim Medinipur Division-I & Head of PIU for Preparation of specified formats to derive the final score and consequently online OMMAS entry under PMGSY-II module as directed by NRIDA
4. Consultants should agree for modification & correction as required and directed by NRIDA till the finalisation of DRRP & CUPL.

TERMS AND CONDITIONS:-

1. The consultants have to prepare DRRP of individual block separately and the rate should be quoted both in fig and words for each group of Blocks.
2. **The intending consultant should submit Earnest money amounting to Rs. 10,000.00 (Rupees Ten thousand) only in the form of Demand Draft / Banker's Cheque in favour of "Executive Engineer, WBSRDA, Paschim Medinipur Division payable at Midnapore.**
3. The Intending consultant should submit self attested copies of PAN, Trade License, documents In support of proof of the PT etc along with the offer document.
4. The Intending consultant should submit self attested copies of documents in support of proof of the Experience along with the offer document.
5. The Successful Consultant(s) should execute an Agreement with EE, WBSRDA, Paschim Medinipur Division-I as per prevailing norms.
