**NOTICE INVITING TENDER-II**

Sealed tenders separate with rate of items are invited from the reliable and bonafide organizations/suppliers for the supply of different kinds of vegetable seed for distribution of Minikit among 29 (Twenty nine) Panchayat Samities of Paschim Medinipur District as specified below. The Tenders will be deposited in the Tender Box to be kept in the office of the undersigned separately i.e., one envelop for technical bid and other will be commercial bid. Tenderer who will fulfill the technical bid only his commercial bid will be opened.

1. Name of Work / Supply : Supply of **Vegetable Seed Minikits in Composite Packets.**
2. Producer/Dealer/Supplier eligible to participate in the tender : **Bonafide Producer/Dealer/Supplier who deals with OP, Hybrid Vegetable and other seeds and also having credentials of supplying similar nature of supply of value Rs. 20.00 lakh minimum in last 5 years.**
3. Estimated value for supply of the items : Rs. 60.00 Lakh
4. Earnest Money : Rs 25,000/- (Rupees twenty five thousand) only in the form of Bank Draft/Deposit at Call Receipt drawn on any Nationalized Bank in favour of District Officer, FPI & Horticulture, Paschim Medinipur.
5. Security Deposit : 10 % of the value of "Supply Order"
6. Time of Completion for supply of seed kits to Block level : Within 20 days from the date of issue of the Supply Order.
7. Last date and time of dropping Tender : 12.30 pm. of 18.08.2011
8. Date and time of opening of sealed Tender : 1.00 pm. of 18.08.2011

**Supply of Different Kinds of Vegetable Seeds (OP and F1) for supply to 29 (Twenty Nine)  
Panchayat Samities of Paschim Medinipur District**

**Terms & Conditions**

1. Successful Tenderers shall have to execute an Agreement with the Office of the District Officer, Horticulture, Paschim Medinipur on a **Non-judicial Stamp Paper** of Rs. 100/- (Rupees one hundred) only within the date specified in the letter of intimation.
2. The intending Tenderers shall have to furnish the copy of the Seed License, Proof of Dealership/Producer, PAN, Trade License, Current I.T. Return, Sale Tax Documents, VAT Registration, Professional Tax Clearance, Credential Certificate, etc. from the appropriate authority along with the application.
3. Rate should be quoted including VAT.
4. No tender will be accepted without Earnest Money.
5. Each page of Tender shall be signed by the Tenderer before submission of Tender Paper.
6. The kind of supply must be written on the envelop.
7. In case of F1 variety of the seed items in the minikit, the Tenderer should select renowned variety from renowned/reputed institute / organization which are suitably cultivated in Paschim Medinipur District with a good reported performance maintaining the specification of the variety as mentioned in the Tender Paper and also write the name of the variety and manufacturing institute/ organization in the Tender Paper. Supply should be done in sealed packets of producing agency and the valid R&D certificate of seed producing agency (for F1 seed) should be submitted along with Tender Paper.
8. Supply of composite packets should be made to the 29 Panchayat Samities of the District of Paschim Medinipur with the own cost of the successful Tenderer.
9. The result of Seed Testing in the Government Laboratory should be binding upon the Tenderer as per Seeds Act.
10. The tenders, which do not fulfill any of the above conditions or incomplete in any respect, are liable to be summarily rejected.
11. Payment will be made from the Office of the District Horticulture Officer, Paschim Medinipur in such a manner that 60% of the total payment will be made after getting satisfactory delivery report from the 29 Panchayat Samities and rest 40% amount will be paid 90 days after 1<sup>st</sup> payment considering the satisfactory result/report from the Field / Panchayet Samity / Executive Officer of Different Blocks and Govt. Laboratory (Seed Quality Judgment).
12. The entire component of the minikit except Item No. 5 i.e., Elephant Foot Yam should be supplied between end of August to middle of September, 2011 and the item no. 5 i.e. Elephant Foot yam should be supplied between January – February 2012.
13. The authority reserves the right to reject or accept any or all tenders without assigning any reason whatsoever.
14. The authority also reserves to the right to choose any kind of item or items.
15. The authority is not bound to accept the lowest tender.
16. If the successful tenderer denied to accept the offer letter then his Earnest Money will be forfeited. In case of failure to complete the supply work within the stipulated time, his offer letter will be cancelled and Security Deposit will be forfeited without assigning any reason thereof.
17. In case of successful tenderer the Earnest Money will be converted into Security Deposit and the rest amount of Security Deposit will be deducted from the 1<sup>st</sup> bill of the 60% of the supplied value.
18. In the event of tender being submitted by a purchaser / supplier, it must be signed by each member thereof and in the event of absence of any partner, it must be signed on his behalf by a person holding a power of attorney authorizing him to do so.
19. The Tenderer shall have to submit the attested photocopy of all related documents along with the tender paper.
20. All papers shall be verified with the originals.
21. The Security Deposit Money will be refunded after successful delivery of the items and getting satisfactory field report as well as Laboratory report. Also, if the tenderer will not supply the 2<sup>nd</sup> phase of the Seed i.e. Elephant Foot Yam, in that case his Security Deposit will be forfeited.
22. To ensure the seed quality, seed samples will be drawn from the main stock (wherein intact packets of certified / truthfully leveled seeds produce by renowned seeds companies/producers to be stocked before making composite packets) as well as from the composite packets so prepared and supplied at the block end for testing in any notified seed testing laboratory of our state. In the case of any discrepancy noticed from the supplied materials of F1 varieties regarding genetic purity, the seed materials may be tested in the Laboratory as a DNA Test. In this situation, the payment of the particular variety under DNA test will be made after getting satisfactory report from the Laboratory.
